

Privacy Statement of Scannexus | Brains Unlimited B.V.

Brains Unlimited B.V. also trading as Scannexus, with its registered office at Oxfordlaan 55, 6229 EV Maastricht, the Netherlands, is responsible for processing personal data as set out in this privacy statement. We respect the privacy of all our visitors. We moreover comply with existing privacy laws and regulations.

This privacy statement informs you how we process your personal data.

#### Personal data

Brains Unlimited B.V. processes your personal data because you use our services and/or provide them to us yourself. We only process personal data that you provide directly or that are clearly provided to us for processing.

Depending on the service you use, we may collect the following data:

- first name and surname;
- address details;
- sex;
- date of birth;
- place of birth;
- telephone number;
- email address;
- data concerning your health;
- information about your appointment;
- IP address;
- payment data;
- insurance data;
- partner;
- practitioners (family doctor, specialist, etc.);
- your diagnostic examination results (laboratory results; images such as X-rays; CT scans; ultrasound and MRI images);
- reports and opinions of attending physicians, including any translations.

#### Special personal data

Brains Unlimited B.V. may process the above data concerning your health if required for the purpose of its services.

#### Purposes and bases of data processing

The personal data we collect are used for the following purposes:

- to be able to perform our services;
- to keep your medical file up to date;
- to schedule an appointment;
- to arrange medical procedures;
- to keep track of your indicated preferences;
- to improve our services to you;
- to perform other services that you request;
- in case of archiving: for historical, statistical, or scientific purposes;
- to provide a translation of medical reports with findings by an attending physician;
- to keep results from earlier examinations and/or treatments;
- to inform you about changes to our services and products;
- to send you our newsletter;
- to process your payment.

# Provision of your personal data to third parties

Brains Unlimited B.V. shares your personal data with various third parties if this is necessary.



To perform our services and comply with any legal obligation. Unless required by law, we will share your data with third parties only with your express consent.

When we provide your data to a third party, we will ensure with an agreement that your data will not be used for other purposes. We will also stipulate in this agreement that your data will be deleted once they are no longer needed.

#### Automated decision-making

Brains Unlimited B.V. does not make decisions based on automated processing on matters that could have significant consequences for individuals. These are decisions made by computer programs or systems without human intervention (for example an employee of Brains Unlimited B.V.).

## Retention periods

Brains Unlimited B.V. will not retain your personal data longer than is strictly necessary to achieve the purposes for which they are collected. This excludes data that we must retain longer because we are required to do so by law.

#### Security measures

Brains Unlimited B.V. takes the protection of your data seriously. We therefore have adopted appropriate organizational and technical measures to prevent misuse, loss, unauthorized access, unwanted disclosure, and unauthorized alteration.

Our employees with access to your personal data only have access to those data needed for performing their duties and/or supporting the website.

#### Your rights

You have various rights that you may exercise in relation to the processing of your personal data. For example, you have the right to access, rectify, and erase your data. Blacken out your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number, and Citizen Service Number (BSN) in this copy. This to protect your privacy. We will respond to your request as soon as possible, but within no more than four weeks.

We wish to point out that you may submit a complaint to the national supervisory authority, the Dutch Data Protection Authority (*Autoriteit Persoonsgegevens*).
